To submit a valid written protest, download and complete the protest form found on Placer LAFCO's website (<https://www.placerlafcoa.gov/noticeofprotesthearing>) or submit a writing containing the same information. The written protest must include your printed name and residence address exactly as they appear in the voter records of the Placer County Elections Office, your signatures, and the date of signing.

If you are a registered voter and a landowner of land located within the territory to be reorganized, you may submit a written protest as a registered voter and landowner (please submit a separate written protest for each category).

To be considered valid, written protests must be signed, dated, and filed with LAFCO between the date of the publication of the Notice of Protest Hearing (March 2, 2026) and the conclusion of the protest hearing. Any person who has filed a written protest may withdraw that protest at any time prior to the conclusion of the hearing.

Before the day of the protest hearing, written protests may be emailed to lafco@placer.ca.gov or mailed or hand-delivered to the LAFCO administrative office at 110 Maple Street, Auburn, CA, 95603. If you mail a written protest, please be aware that it must be actually received by LAFCO prior to the conclusion of the protest hearing to be considered timely filed. On the day of the protest hearing, written protests must be hand-delivered to the LAFCO Executive Officer or the Executive Officer's designee at the protest hearing location.

After the conclusion of the protest hearing, the LAFCO Executive Officer will determine the value of all written protests and the next step for the project, which may be to (1) order the reorganization subject to an election or (2) order reorganization.
